We are proud and forward-looking to report that our building is unending; that our integrated programs, direct services and financial standing stabilized in this post-pandemic period. We are energized and focused on helping those we serve unlock their potential today to set the table for their brighter tomorrow.

Serving the community as a vibrant agency that has a positive impact on children, youth and families means continually assessing and refining UCAN's programs and operations. Like other non-profits, we know the critical importance of being flexible during and after a pandemic that required establishing and streamlining ways of communicating and engaging with each other and those we serve. In Fiscal Year 2022, that reality was a driving force behind our multi-pronged Strategic Direction that guided our work agencywide.

The plan enabled us to revisit and refine our program structure and create three hubs that even more accurately define UCAN's evolution: Foster Care & Transitional Services; Therapeutic & Clinical Services; and Prevention & Empowerment Services. We know, however, that regardless of labels, our dedicated staff remain the change agents and dream facilitators for those who need and rely on UCAN's expertise. We are working with our funders, partners and peers to ensure that these three hubs smartly reflect our plan to further integrate our work that is the foundation of UCAN's Continuum of Care.

UCAN ACADEMY

- 100% of teacher lesson plans include social and emotional learning and 100% of social work lesson plans include diversity at both campuses.
- APEX's Credit recovery program resulted in students graduating on time and/or putting them closer to being on track for graduation.

RESIDENTIAL

- The Residential Therapeutic Home implemented an exciting new music therapy group that focuses on youth relating music to their thoughts, actions, and behaviors. This program allows them to write and create music, learn the music industry, break down music, process the meanings of the songs, and relate them to their lives and situation. This program has served over 40 youth, while providing a sensory room to allow them an escape to drain emotions and meditate on their coping skills.
- Youth were able to attend a 4-day camp retreat in Outdoor Wisconsin Leadership School camping site in Lake Geneva, Wisconsin. The youth participated in high ropes, motorboat rides, water, and jet skiing and many other team and fun recreational activities while lodging on the camp site.
- Fiscal Year 2022 had an increase of successful youth discharges to foster care and Transitional Living Program placements six within the UCAN continuum of care and three youth to return home.

WORKFORCE DEVELOPMENT SUCCESS STORY

Dujuan Matthews is one of our Chicago Housing Authority/Employee Placement Services participants. Dujuan was placed with Addus Healthcare and is still on their work schedule doing a great job. He also attends Olive Harvey College where he is a member of the Black Student Organization and the After School Activities President. Dujuan spends a lot of his time advocating for his peers and connecting them to resources that were available to him. Through his connection with UCAN, he shares flyers of hiring events, community events, and training opportunities with his peers to promote personal and professional development. Dujuan is devoted to the success of himself and everyone else around him.

YOUTH DEVELOPMENT SUCCESS STORY

Mariell Macon, a high school junior, joined UCAN Survive in September 2022, referred by his youth development coach due to challenges in his social environment. After a traumatic event in 2019, his family moved to Plainfield, Illinois, seeking a better environment. Struggling to adjust, Mariell faced bullying and isolation in his predominantly white neighborhood. With UCAN's support, he accessed academic help and joined social groups. Encouraged by his coach, he also joined school sports teams, which boosted his confidence and focus on academics. Mariell aspires to attend college on an athletic scholarship, recognizing the impact of his actions on personal development and success.






